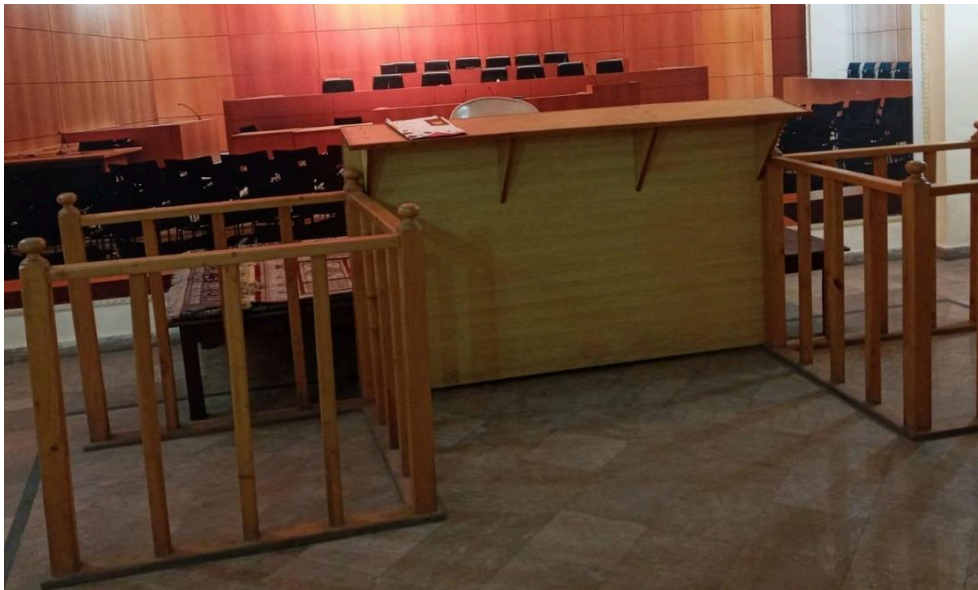

LAW MOOT ROOM IN NATIONAL PUNJAB LAW COLLEGE

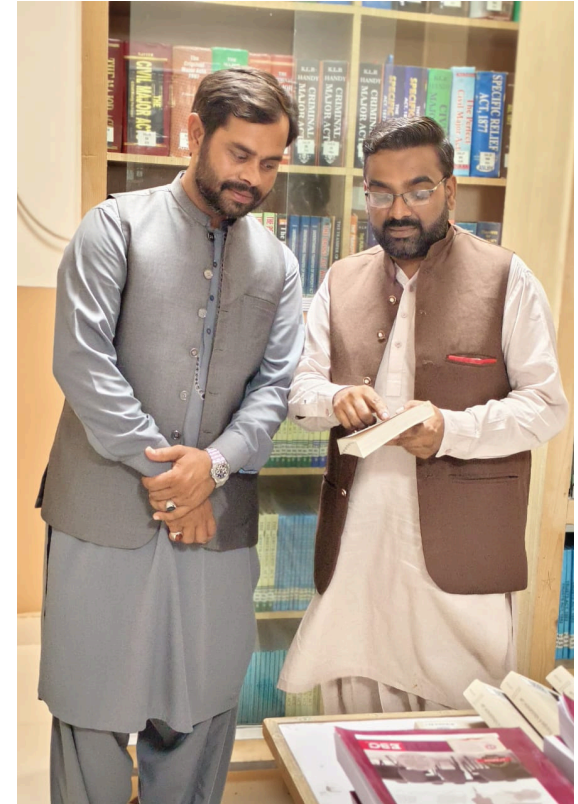
SPORTS ACTIVITIES
